Marshall: perhaps demonstrate the 40% and the 13% differently on the "red garbage bag graphic"

Rachel: What do you want people to do with this information? If its contamination, we need to make that more apparent at the beginning of the document. We should put the data alongside the recommendations to make more inviting

Javier: Recommends key takeaways, make references to weight to something people could imagine "this weight is the same as a hippo for example" to cater to people who have difficulty analyzing data

Marshall: wants to know if we could add space to the graph on page 10 of Annual Report – UWinnipeg has far more space but is also using energy far more efficiently

Kyle: Believes report should contains some more real photos

Chris: If the new bins aren't making improvements next waste audit – then it is probably because staff areas are lacking in staff areas and offices.

Rachel: Wants to work with us to improve the UWinnipeg research section. The library is working on a better way to search for such research.

lan: wants to us to show local procurement on our report to better represent Diversity's sustainability

Marshall: water consumption — covid years affected this — perhaps look at providing an expected projection of water consumption

Navinder: What is the reason for 1990 and 2007's data being missing from the table on page 28 of the Annual report?

Javier: Just curious if there is a standard Canadian reporting guideline for campuses?

Joe: Yes, the standard reporting tool for campuses is STARS

Kyle: there is also the Climate registry, and Portfolio management — which can be used to incorporate data into future reports

Commuter Survey – Sara Campbell

Joe: We could possibly look at implementing the same structure as Go Manitoba to our own UWinnipeg staff.

Rachel: Are you aware that there are bike cages on campus that aren't allowed to be used because of high rates of theft? This was just this summer and last summer.

Javier: Curious to know what the top reasons for why people are taking public transit and active transit.

Sara: I believe the main reasons were 1. no other choice, 2. health benefits, and 3. affordability

Are bikes allowed in offices? It would promote more active transport

Kyle: the terms have changed to open the opportunity to allow it

Marshall: A problem then arises when it comes to space and being a good neighbour.

Marshall: there are ways to solves to bike theft problems by producing secure bike storage or a bike storage garage

Trish: Suggestion to bring it up to the AMA committee regarding accessibility about bin placement
